For the purpose of Article 17.2 of the Constitution, the Government recommend that it is expedient to authorise such payments out of moneys provided by the Oireachtas as are necessary to give effect to any Act of the present session to amend the Electoral Act 1992, the Referendum Act 1994 and the Presidential Elections Act 1993 in order to change island voting and to provide for related matters.
