acknowledges:

- that Ireland has the second lowest forest cover in the European Union (EU) at 11 per cent, compared to a European average of 30 per cent and that the majority of the forests are monocultures;
- that the State forestry policy has been predominantly based on a rotation, clear-fell and replant cycle using monoculture;
- that the extent of hedgerows declined massively during the 20th century but has since recovered slightly;
- that having started from a forest cover of 1 per cent in 1923, the State and the forestry industry has grown substantially, and afforestation has brought major positive benefits including the development of a forestry sector and forest products industry that currently employs 12,000 people;
- that aspects of the current afforestation model, in particular the emphasis on large-scale monoculture have, in some cases, had negative impacts on local communities, biodiversity, water quality and landscapes;
- that in the light of the need to address the challenges of the climate and biodiversity emergency, now is the time to move to the next stage in Irish forestry;
- that it is desirable for the forestry system to provide a range of services in a way which strengthens local communities, provides employment for a new generation of foresters and access for the public to more varied woodlands, which are rich in biodiversity;
- that there is a potential for higher value, higher quality wood products from Irish forests, including a potential for long-lasting products as low carbon inputs for construction and other sectors and as stores of sequestered carbon for the lifetime of the buildings and products;
- the declining populations in certain rural areas, the high average age of farmers, and the developing crisis in Irish agriculture; and

- the inappropriate nature of current land use in many parts of Ireland, including the inability to make a living from current farming models and the difficulty for young people who might want to work on the land to get access to land which they do not directly inherit;

notes:

- the impacts of biodiversity loss and the loss of ecosystem services, and the consequent economic losses and risks we face globally and in Ireland;
- the gravity of the global biodiversity crisis, including the loss of species, the loss of important populations of species and the undermining of ecosystem services;
- the vital role of land use in the hydrological cycle, managing flooding and drought, maintaining water quality and dealing with pollution and the role which changed land use practices must play in meeting the objectives of improving water quality in line with the EU Water Framework Directive;
- the vulnerability of even-aged monoculture plantations, e.g. to disease, fire and windthrow, especially given the increasing dangers of climate change;
- the role which changed land use practices must play in reducing greenhouse gas emissions in sequestering and storing carbon, and in providing resilience to the effects of climate change;
- the essential role that afforestation, land use and soil carbon management must play in Ireland's National Energy and Climate Plan (NECP) 2021-2030, which is to be drafted by the end of this year; and
- the commitments Ireland has entered into, in the context of the Natura 2000 network and the EU Birds and Habitats Directives to protect habitats and species, and the fact that Ireland is failing to meet those commitments and that biodiversity loss is continuing, as demonstrated in Ireland's reports under Article 16 of the EU Birds and Habitats Directive;

agrees:

- that Ireland was once covered by great forests and that our mild climate and the influence of the Gulf Stream make for one of the best habitats for trees in the world;
- that the Irish population wants to spend more time in nature and the public health benefits of enabling them to do so;
- the economic value of ecotourism and associated economic activities; and
- that the success of rewilding initiatives in other countries, and the plans for a recognised wilderness area in the Nephin range, as well as Coillte's recent recognition of the amenity value of forestry in the Dublin and Wicklow mountains; and

calls on the Government to:

- make a fundamental change in forestry policy away from a narrow vision of 30 year cycle to a permanent woodland approach that would provide greater and more diverse social, environmental and economic benefits to society as a whole;
- move away from large-scale monoculture of fast-growing species such as Sitka spruce on 'marginal land' towards mixed, diverse forestry, with a wider range of forest types (short rotation, longer rotations, agroforestry, semi-wild) delivering a range of services and benefits and forest products;
- rebalance the premiums and payments made for planting and thinning to support this strategic change in Irish forestry;

- start the restoration of large areas of natural woodlands, formerly the dominant terrestrial ecosystems of Ireland, including the productive use of much of them through a system of continuous cover and close to nature forestry;
- begin a national programme of transformation of existing young, even-aged monoculture forests to continuous cover forestry;
- implement the recommendation of the Oireachtas Joint Committee on Climate Action, accepted and endorsed by the Dáil on 9th May, for a review of land use to inform a national land use plan;
- establish a system of local forestry plans, developed in an open participative process including all parts of civil society, in each county, informed by the national land-use plan, which would form the framework for Government support for small-scale afforestation in the county;
- use Strategic Environmental Assessment to develop these local forestry plans, to ensure the meeting of objectives, including carbon sequestration, water quality and hydrology, biodiversity protection and restoration, landscape and public amenity;
- provide for these local forestry plans to include financial support for small-scale afforestation with mixed woodland with a high proportion of native species in all parts of the country;
- provide budgetary support to enable every registered farm holding to plant a hectare of natural woodland on their land within the next five years, on agreed sites within the farm which minimise the effect on farm operations and maximise the biodiversity and ecosystem service benefits;
- develop opportunities for community ownership of and community investment in afforestation within national forestry policy and local forestry plans;
- reorient national supports and incentives for afforestation in line with the local forestry plans in the direction of forestry closer to nature;
- provide better support for the restoration and planting of new hedgerows to provide biodiversity corridors, carbon shelters and nutrients in our agricultural system;
- engage local authorities and local communities in a radical expansion of urban tree planting and neighbourhood and community forests and for urban trees and forests;
- resource the National Parks and Wildlife Service, the National Council for Forest Research and Development (COFORD) and forestry non-governmental organisations (NGOs) at a level appropriate for them to carry out all of their functions and develop new areas of responsibility;
- review the objectives and legal structure of Coillte to establish a new mandate for the company which delivers multiple benefits from forestry, including environmental and community objectives as well as the production of high-quality timber;
- establish better educational infrastructure and funding to support apprenticeship programmes in forest management in line with the new forestry policy;
- increase investment in higher and further education and training as well as for the modernisation of equipment available for craft apprenticeship provision to conduct such a transformation of existing strands; and
- promote the use of high-quality wood materials in new building construction, including by amending building regulations, and to encourage Irish enterprise agencies to further support the development of local enterprises which develop a wide

- that the Department of Agriculture, Food and the Marine provides support, through schemes such as the Green Low-Carbon Agri-Environment Scheme (GLAS) and under the Forestry Programme 2014 – 2020, to landowners to undertake actions and

measures which support and enhance biodiversity; and

recognises:

- the role that hedgerows play in nature-based solutions to both mitigate climate change (carbon sequestration and storage) and help in the creation of landscape resilience in the face of climate change, and notes that 6,758 kilometres of new hedgerows have been established since the introduction of agri-environmental schemes in 1994;
- the funding provided under the Department of Agriculture, Food and the Marine NeighbourWood Scheme to local authorities and other landowners, both public and private, to create ‘close-to-home’ woodland amenities in partnership with communities, for local people to use and enjoy;
- the growing interest in planting native woodlands under the Forestry Programme 2014 – 2020 is increasing steadily year on year with 374 hectares of native woodlands planted in 2018, an increase of 38 per cent compared to 2017, and this upward trend has continued into 2019 which is ahead of the 2018 planting figure year to date;
- that under the Woodland Improvement Scheme which promotes active management of broadleaf forest, almost 680 hectares of woodlands received support under this scheme this year, this represents a 76 per cent increase in activity when compared to the same time in 2018;
- that support for Continuous Cover Forestry was introduced for the first time in the MTR of the Forestry Programme 2014 – 2020, where funding was allocated for 30 projects up until the end of 2020;
- the establishment by Coillte of a specific entity ‘Coillte Nature’ within the company to focus on the environment and recreational forests, with Coillte Nature to target the delivery of new woodlands facilitating species diversity, biodiversity and carbon sequestration as part of the Forestry Programme 2014 – 2020;
- that Coillte Nature will be undertaking large discrete projects with a separate non-commercial focus, with the intention of increasing the national forest estate but with a strong emphasis on carbon sequestration, species diversification, biodiversity and the development of outdoor recreation and tourism amenities;
- that the National Council for Forest Research and Development (COFORD) proposes to track the implementation of the recommendations in ‘Forests, products and people – Ireland’s forest policy – a renewed vision’ and to monitor and report on progress in implementing the stated strategic actions and to engage and influence stakeholders in relation to policy changes and developments focusing on afforestation and the promotion of forestry; and
- that the continued support of members of the House will be required for the ongoing development of forestry in order to maximise the range of benefits for the economy, society and the environment.” (*resumed*) — *An tAire Talmhaíochta, Bia agus Mara*.

- that taken together, Budget 2018 spending and ‘the Budget 2019 plans are not conducive to prudent economic and budgetary management’;
- repeated budgetary failures have ‘left the public finances more exposed to adverse shocks’;

- over-reliance on corporation tax has inhibited net policy spending rising ‘in line with sustainable revenues’; and

- a chairperson, to be appointed by An Taoiseach;
- a minimum of 66 citizens, randomly selected so as to be broadly representative of Irish society and who are entitled to vote in a referendum and in local authority elections;
- one member from each of the political parties of the Northern Ireland Assembly;
- one member appointed by each political party/grouping of the Oireachtas; and
- substitutes, who may be appointed by each political party/grouping, and who will be entitled to full participation rights, including the right to vote; and

further agrees that:

- the Citizens' Assembly-
 - will agree its own rules of procedure to ensure effective conduct of its business which will be done in as economical a manner as possible;
 - will give appropriate regard to the conventions and clauses contained within the Good Friday and St. Andrews' Agreements;
 - will present an interim report to the Houses of the Oireachtas, including its recommendations, within two months of completing its deliberations; and
 - may invite and accept submissions from interested bodies and members of the public, and will seek advice and guidance whenever necessary to aid its members in their deliberations;
- all matters before the Citizens' Assembly will be determined by a majority of the votes cast by members present;
- the chairperson will have the casting vote in the event of a hung vote; and

commends the whistleblowers who have highlighted this matter and undertaken research in order to determine relevant facts in relation to the impact of lack of appropriate health and safety on Air Corps personnel;

calls on the Government to:

- commit to putting in place and maintaining full training, personal protective equipment and ventilation in order to minimise the risks to Air Corps personnel of toxic chemical exposure;
- outline the steps it intends to take to address the concerns raised by whistleblowers and ensure the highest possible standards of health and safety for Air Corps personnel; and
- put in place measures, including medical cards, to address the health needs of personnel that have been exposed to hazardous chemicals, and extend these measures to any civilians affected and to students who may be affected while on work experience; and

notes that:

- it is estimated that 90,000 to 180,000 people are affected by fibromyalgia in Ireland;
- fibromyalgia is a debilitating condition, with chronic pain and fatigue being the primary features;

- there are no nationwide specialist facilities or comprehensive treatments available;
- those living with fibromyalgia have encountered difficulties when trying to access social welfare, and instead of getting vital support at a crucial juncture in their illness, they are being refused and stigmatised, and as a result experience stress;
- the condition is significantly misunderstood; and
- the majority of those affected by fibromyalgia are women, at a ratio of 6:1;

agrees that:

- a national registry of the chronic pain syndromes and clinical guidelines for different types of chronic pain, as per the International Classification of Diseases codes and International Association for the Study of Pain – World Health Organization (WHO) guidelines, be drawn up to assist medical practitioners to better understand different types of chronic pain syndromes and to be able to differentiate according to WHO international guidelines;
- the delivery of care is limited by the lack of commitment to the diagnosis and treatment of fibromyalgia in addition to the deficiencies in resources currently available in community, primary and secondary care;
- the delivery of care is also hampered by the absence of clear guidelines for management, and the lack of opportunity to develop integrated care pathways across primary and secondary care;
- many people with fibromyalgia suffer from chronic pain;
- access to psychological therapies is a paramount need in health service development, together with improved access to all multidisciplinary health treatments;
- patient education and self-care is a vital aspect of management of fibromyalgia and optimal benefits are obtained when sufferers acquire skills in helping reregulation of the autonomic nervous system and other systems as well as pain and stress management skills;
- access to a recognised pain programme and pain psychologist, autogenic training, mindfulness and yoga can be especially helpful as part of comprehensive cognitive behavioural therapies, as well as appropriate exercise to improve mobility and function together with dietary adjustment, and in some cases the person with fibromyalgia is able to return to work;
- fibromyalgia should be recognised as a disability by the State for people with severe symptoms who have the condition on a long-term basis and which has proved unresponsive to interventions, and in these cases alternative treatments such as access to medicinal cannabis should be explored, and access to medicinal cannabis through the Cannabis Access Programme should be considered; and
- reliance on opioid based medicines is not desirable; and

calls on the Government to:

- establish an effective and sustainable model of care to diagnose, manage and treat fibromyalgia;
- bring an end to prescription charges;
- reduce/remove the monthly limit on the cost of medications for non-medical card holders;

- develop a model of care based on international best practice;
- implement a strategy to set up a framework where those living with fibromyalgia and myalgic encephalomyelitis (ME) are clearly recognised;
- conduct a review of the long-term illness scheme, as it has not been updated since 1970 (49 years ago);
- carry out a dedicated and rigorous review of the underlying causes of the condition; and
- roll-out a comprehensive education programme for those working in social welfare, dealing with people with chronic pain of all types.” — *Gino Kenny, Richard Boyd Barrett, Brid Smith, Mick Barry, Ruth Coppinger, Paul Murphy, Thomas P. notes that there are approximately 70 people, including 26 children, in Ireland with Spinal Muscular Atrophy (SMA), which is a rare and life-limiting muscle-wasting condition;

further notes that:

- SMA is the number one genetic cause of death for infants worldwide;
- SMA will affect around 1 in 11,000 babies born worldwide each year;
- there are four different types of SMA, with Type 1 SMA being the most severe and most common;
- Spinraza (Nusinersen), produced by Biogen, is the first treatment for SMA and is available in 25 of the 28 countries in the European Union;
- in February 2019, the Health Service Executive (HSE) did not approve Spinraza (Nusinersen) for reimbursement and negotiations with Biogen are ongoing;
- patients deteriorate when they stop taking Spinraza (Nusinersen) and real life testimony has been given to confirm the efficacy of the drug;
- 25 of the 64 Health Technology Assessment (HTA) reports which were submitted in the period from 1st January, 2016 to 30th November, 2018 related to orphan medicines, with 12 of these having been approved at the beginning of January 2019, and ongoing deliberations or commercial negotiations are continuing for 13 of these medicines;
- a 2017 Grant Thornton review of the National Centre for Pharmacoeconomics (NCPE), indicated that it was understaffed, at 8.5 whole-time equivalents, and that an additional 9 staff, including senior pharmacists, HTA assessors and statisticians, would be required to meet the additional workload; and
- with revenue and profits often in the billions, pharmaceutical companies also have a moral obligation to enter into negotiations with fair pricing, so as not to prolong the reimbursement assessment and deliberation process; and

calls on the Government to:

- meet with adults and children with SMA, and their parents, to listen to their call for Spinraza (Nusinersen) to be approved for reimbursement;

- urgently direct the HSE to speed up negotiations with Biogen, the pharmaceutical company producing Spinraza (Nusinersen), because time is of the essence for these patients;
- increase the resources available to the NCPE and the HSE Corporate Pharmaceutical Unit to allow for a quicker assessment, negotiations and approval of new treatments;
- reduce the time allowed under the Framework Agreement on the Supply and Pricing of Medicines, and in line with the Health (Pricing and Supply of Medical Goods) Act 2013, for a decision by the HSE from 180 days of receiving the application down to 90 days, with a maximum of 120 days if further information is needed from the company;
- revise the National Rare Disease Plan for Ireland 2014-2018, and include greater input from patient advocacy groups and improve the remit of the Rare Diseases Medicinal Products/Technology Review Committee, to be in line with the Scottish Patient and Clinician Engagement model;
- introduce an orphan drugs levy on pharmaceutical companies and create an orphan drugs fund;
- provide a report to Dáil Éireann by the end of quarter 3, 2019, to outline the impact of our membership of the BeNeLuxa initiative; and
- ensure that the review of the HSE reimbursement and pricing decision-making process is completed by the end of quarter 3, 2019.” — *Thomas P. Broughan, Thomas Pringle, Joan Collins, Catherine Connolly, Maureen O’Sullivan, Gino Kenny, Bríd Smith, Richard Boyd Barrett.*

- the potential for rapid and far-reaching climate change policies to significantly improve people’s lives, create sustainable jobs, empower communities, and develop promising and resilient societies; and
- the role of young people in the recent climate strikes in highlighting the urgency of the issues at stake;

deplores the fact that 60 per cent of animal species have been wiped out since the 1970s, according to the Living Planet Index, which is adopted by the Convention on Biological Diversity as an indicator of progress on biodiversity;

expresses deep concern at the United Nations Environment Emissions Gap Report 2018, which notes that current commitments in Nationally Determined Contributions submitted under the Paris Agreement are inadequate to bridge the emissions gap, outlining the global trajectory for emissions with the current level of climate ambition at 3.2°C, although noting it is technically still physically possible to avoid exceeding 1.5°C;

hereby declares a climate and ecological emergency, thus, requiring an emergency response to both the climate and ecological crisis; and

260. “That Dáil Éireann:

notes that:

- Seamus Ludlow, a 47-year-old, unmarried forestry worker from Thistle Cross, Dundalk, County Louth, was killed in the early hours of the morning on 2nd May, 1976, he was shot a number of times and to date, no-one has been charged with his murder;
- the Garda investigation was suspended after three weeks without explanation and on the basis of what a Garda told the family were ‘orders from Dublin’;
- in a letter to the Gardaí in January 1979 the Royal Ulster Constabulary (RUC) identified four suspects, these men were arrested by the RUC in February 1998, almost 20 years later;
- according to the Oireachtas Joint Committee on Justice, Equality, Defence and Women’s Rights, the Report of the Independent Commission of Inquiry into the Murder of Seamus Ludlow published in March 2006:

‘During the course of questioning two of the four men admitted being present when Seamus Ludlow was murdered but denied being involved. A file was then sent to the Director of Public Prosecutions in Northern Ireland for a decision on whether charges should be brought against these men. No prosecution was brought on the basis of insufficient evidence.’;

- the Committee further found that the ‘investigation into the murder of one of the State’s citizens stopped despite the fact that four suspects had been identified. No matter how turbulent the times, the investigation into the murder of a citizen of the State should not be sacrificed for any reason.’;
- the Committee also recorded ‘its disappointment at the lack of co-operation from the British authorities’;
- the Committee, in respect of the role collusion may have played in the murder, reported:

‘It can only say that it has the gravest of concerns about the role collusion played in the murder of Seamus Ludlow. It is undisputed that two of the suspects identified by the RUC were serving members of the UDR at the time of the murder. The suspicion of collusion arises so strongly because of the following three facts:

- (1) Two of the suspects were serving members of the UDR.
- (2) The fact that the brother-in-law of Seamus Ludlow, Mr. Kevin Donegan, was kidnapped the day after the funeral by the British Army, who wanted to know what the Gardai knew about the case.
- (3) No notes of the interrogation of Mr. Kevin Donegan by the British Army have ever been made available by the British authorities.

There are disturbing parallels between the role collusion played in the murder of Seamus Ludlow and the role collusion played in the Dublin and Monaghan bombings, as discussed in the previous two reports of this Joint Committee.’;

- the Committee Report concluded that two Commissions of Investigation should be established;

— the terms of reference of the first Commission of Investigation would include investigation of the following:

- i. Whether the evidence collected at the scene of the murder of Seamus Ludlow in 1976 was available in 1979 and if not, why not?
- ii. Why were credible leads given to the Gardaí by the Northern Ireland police force not followed up?
- iii. Why were the four named suspects not interviewed?
- iv. was there a policy in existence not to interview suspects in Northern Ireland for crimes committed in this jurisdiction?
- v. Was a decision taken not to actively pursue the investigation of the murder of Seamus Ludlow and if so, who took that decision and why?';

— the terms of reference of the second Commission of Investigation would include investigation of the following:

- i. What documents were created or maintained by An Garda Síochána including security intelligence C3 Section in relation to the murder of Seamus Ludlow?
- ii. Where are those documents?
- iii. If those documents are not available for inspection what is the reason for this?
- iv. What documents were created or maintained by the Department of Justice (and Departments of An Taoiseach, Foreign Affairs and Defence, in respect of the Cabinet Sub-Committee on Security), in relation to the murder of Seamus Ludlow?
- v. Where are those documents?
- vi. If those documents are not available for inspection what is the reason for this?';

recognises that:

- successive Ministers for Justice and Equality have repeatedly refused to establish the Commissions of Investigation as recommended by the Committee in its final report on the Report of the Independent Commission of Inquiry into the Murder of Seamus Ludlow (March 2006);
- in November 2017, the High Court rejected a judicial review by the family against the decision of the Minister for Justice and Equality, and the family have lodged an appeal in respect of this decision and a hearing will be held next year at the earliest;
- the Belfast High Court has ruled that the family can challenge the decision of the Public Prosecution Service (previously the Director of Public Prosecutions) not to prosecute the four suspects; and
- the family are seeking a meeting with the Garda Commissioner and with the Police Ombudsman; and

- Title III of the Act establishes a group of rules that include the possibility of filing lawsuits in US courts on entities engaging in economic activity using such property; and
- Title IV prohibits the entry into the US of executives and their families, and of the owners of entities engaging in economic activity using such property;

acknowledges that:

- all US Presidents since 1996 have consistently suspended application of the provisions of Title III of the Act until 16th January, 2019, when the US State Department announced that it would suspend the Title III waiver for 45 days only (starting on 1st February), in order to conduct a review;
- following expiry of this period, as of 2nd May, 2019, the provisions of Title III now apply and legal cases may be taken in the US against entities engaging in economic activity in nationalised or expropriated property in Cuba;
- citizens and foreign entities, including European Union (EU) citizens, may be subject to legal decisions in the US involving fines, seizure of assets and/or prohibition on travel to the US;
- some lawsuits have already been filed, while none have been filed against citizens or EU entities to date; and
- the EU, Canada, the United Kingdom and other significant US trading partners have issued statements expressing deep concern at the US decision to implement the provisions of Title III of the Act;

declares:

- full support for the statement issued on 2nd May, by the High Representative of the EU, noting that the decision to activate Title III, and opening the way for action under Title IV, is a breach of the commitments undertaken in the EU-US agreements of 1997 and 1998, which had been respected by both sides without interruption since then;
- extraterritorial application of unilateral restrictive measures to be contrary to international law and supports the EU in drawing on all appropriate measures to

address the effects of the Helms-Burton Act, including in relation to its World Trade Organization rights and through the use of the EU Blocking Statute; and

- that the decision by the US will cause unnecessary friction and undermine trust and predictability in the transatlantic partnership; and

calls on the Government to:

- continue to speak out in the strongest possible terms against the application of the Helms-Burton Act, including the recent activation of Titles III and IV;
- support the ongoing action of the EU to request that the US government refrain from enforcing Title III of the Helms-Burton Act;
- uphold its obligations to preserve the rights and interests of citizens and entities and to take action at EU level to protect them from extraterritorial actions, such as those provided for in the Helms-Burton Act;
- continue to work with international partners, which have also voiced their concerns in this regard;
- continue to support resolutions at the General Assembly of the United Nations condemning the US economic and financial economic blockade imposed on Cuba;
- continue to enhance Ireland-Cuba ties following the recently approved terms of the Political Dialogue and Cooperation Agreement between the EU and its Member States;
- commemorate the twentieth anniversary of diplomatic relations between Ireland and Cuba with a series of events to be held in Havana this October.” — *Thomas Pringle, Maureen O'Sullivan, Thomas P. 263. “That Dáil Éireann:

notes that:

- this House declared a Climate and Biodiversity Emergency in May 2019;
- recent extreme weather events, including record heatwaves in Europe and Asia, are a warning that climate change is crossing thresholds that pose a threat to all humanity and life on Earth;

- unprecedented wildfires in the Arctic and Amazon, and an historic rise in methane levels in the atmosphere show the urgency of radical actions;
- the focus of climate change mitigation actions is to reduce the greenhouse gas (GHG) emissions which are driving climate change;
- methane is the second most important GHG behind carbon dioxide causing global climate change, whose impact on climate over a 20-year period is 87 times more potent than that of carbon dioxide;
- unlike the case for carbon dioxide, the climate system responds quickly to changes in methane emissions, and reducing methane emissions could provide an opportunity to immediately slow the rate of global warming and perhaps meet the United Nations Framework Convention on Climate Change (UNFCCC) Conference of the Parties (COP) 21 target of keeping the planet well below 2°C above the pre-industrial baseline;
- the latest peer-reviewed scientific studies have found that shale gas production in North America may have contributed to approximately one-third of the total increased methane emissions from all sources globally over the past decade;

further notes that:

- this State passed the Petroleum and Other Minerals Development (Prohibition of Onshore Hydraulic Fracturing) Act 2017, banning fracking in Ireland in recognition of the health and climate impacts of shale gas;
- New Fortress Energy plans to import fracked gas from America to the proposed Shannon liquefied natural gas (LNG) terminal;
- projects listed as European Union (EU) Projects of Common Interests (PCI) can benefit from accelerated permitting procedures and funding;
- the Shannon LNG project and its enabler project – the reverse flow of the interconnector – are on the fourth proposed candidate list of EU PCI;
- the EU PCI Regulation states that:
 - ‘each individual proposal for a project of common interest shall require the approval of the Member States, to whose territory the project relates’;
 - ‘projects of common interest shall be allocated the status of the highest national significance possible and be treated as such in permit granting processes’;
 - ‘With regard to the environmental impacts addressed in Article 6(4) of Directive 92/43/EEC and Article 4(7) of Directive 2000/60/EC, projects of common interest shall be considered as being of public interest from an energy policy perspective and may be considered as being of overriding public interest, provided that all the conditions set out in these Directives are fulfilled’; and
 - ‘Projects of common interest included on the Union list pursuant to paragraph 4 of this Article shall become an integral part of the relevant regional investment plans under Article 12 of Regulations (EC) No 714/2009 and (EC) No 715/2009 and of the relevant national 10-year network development plans under Article 22 of Directives 2009/72/EC and 2009/73/EC and other national infrastructure plans concerned, as appropriate. Those projects shall be conferred the highest possible priority

within each of those plans’;

- currently it is proposed that six projects for LNGs be included on the EU PCI list (out of a total of fourteen that have received support from the EU since 2013) and that these projects, if built, will result in a massive increase in the use of fracked North American shale gas and subsequent massive increase in methane emissions;
- Ireland has not yet formally approved the final fourth EU PCI list;
- previous statements of support for Shannon LNG by the Government were issued before it became known that this project would be a hub for fracked North American gas and before the extent of methane leakage from this fuel was fully understood; and
- Article 194 of the Treaty on the Functioning of the European Union states that each EU member state maintains its right to ‘determine the conditions for exploiting its energy resources, its choice between different energy sources and the general structure of its energy supply’;

also notes that:

- PCI accreditation sets the framework for development consent;
- no strategic environmental assessment of the proposed activity to import fracked gas into the Irish energy mix has ever been undertaken to assess reasonable alternatives;
- no account has been taken of the full life-cycle emissions of GHGs from fracked gas;
- a policy vacuum exists where LNG terminals and Ireland’s access to the global fracked gas market have not been considered in the ‘National Mitigation Plan’ or in the ‘Draft Statutory Climate Change Adaptation Plan for the Electricity and Gas Networks Sector’;
- previous policy statements that categorised natural gas as a transitional or bridging fuel are mistaken, and that gas is a fossil fuel that can play no long-term role in tackling climate change;
- LNGs and other related infrastructure will lock Ireland and Europe into continued use of fossil fuels and hinder attempts to transition society to renewable sources of energy; and
- facilitating LNGs or the importation of fracked gas from North America will render impossible the immediate goals of radical cuts in GHG emissions; and

recognises that an energy plan facilitating the import of fracked North American shale gas is contrary to the principle and logic of passing a ban on fracking in this State and of urging households and communities to act to reduce their carbon dioxide emissions; and

calls on the Government to:

- remove any project from the priority list of EU PCI that would facilitate the building of an LNG in Ireland that will act as a gateway for fracked shale gas from North America; and
- build support in Europe to prioritise sustainability criteria in the assessment of candidate PCI projects that will address fossil fuel lock in and the long-term impacts of fracked gas in the European energy mix, given the expected change in climatic conditions.” — *Brid Smith, Gino Kenny, Richard Boyd Barrett, Paul Murphy, Ruth Coppinger, Mick Barry, Seamus Healy, Eamon Ryan, Catherine Martin, Joan Collins, Catherine Connolly, Thomas Pringle, Thomas P.
