- b12a.** Go ndéanfar, leis seo, Roghchoistí mar “(1) atá leagtha amach i gcolún (1) den Sceideal a ghabhann leis seo a cheapadh de bhun Bhuan-Ordú 95.
- (2) Déanfaidh gach Coiste na feidhmeanna atá leagtha amach i mBuan-Ordú 95 a chomhlíonadh i leith na Roinne Rialtais nó na Ranna Rialtais atá liostaithe i gcolún (2) os coinne gach Coiste (in oirchill na hOrduithe Rialtais riachtanacha do theacht in éifeacht i ndáil le hainmneacha Ranna agus teidil Airí agus Riarachán Roinne agus Feidhmeanna Aire a aistriú).
- (3) 9 an líon comhaltaí a cheapfar ar gach Roghchoiste.
- (4) Beidh ag gach Roghchoiste na cumhachtaí a mhínítear i mBuan-Ordú 96, seachas míreanna (6) go (10).
- (5) Déanfar gach Roghchoiste a chomhcheangal le Roghchoiste arna cheapadh ag Seanad Éireann chun Comhchoiste a dhéanamh chun na feidhmeanna a leagtar amach i mBuan-Ordú 95, seachas ag mír (5) den chéanna, a chomhall.
- (1) That Select Committees as set out in column (1) of the Schedule hereto are hereby appointed pursuant to Standing Order 95.
- (2) Each Select Committee shall perform the functions set out in Standing Order 95 in respect of the Government Department or Departments listed in column (2) opposite each Committee (in anticipation of the coming into effect of the necessary Government Orders in relation to names of Departments and titles of Ministers and transfer of Departmental Administration and Ministerial Functions).
- (3) The number of members appointed to each Select Committee shall be 9.
- (4) Each Select Committee shall have the powers defined in Standing Order 96, other than paragraphs (6) to (10).
- (5) Each Select Committee shall be joined with a Select Committee appointed by Seanad Éireann to form a Joint Committee to carry out the functions set out in Standing Order 95, other than at paragraph (5) thereof.

- (6) Beidh ag gach Comhchoiste na cumhachtaí a mhínítear i mBuan-Orduithe 96, 133 agus 135. (6) Each Joint Committee shall have the powers defined in Standing Orders 96, 133 and 135.
- (7) Beidh ag an Roghchoiste um Dhlí agus Ceart na cumhachtaí a mhínítear i mBuan-Ordú 134(1)(b). (7) The Select Committee on Justice shall have the powers defined in Standing Order 134(1)(b).
