

- reduce the regulatory burden on small and medium enterprises by introducing a standard costs model approach to regulation and reform the current Regulatory Impact Assessment (RIS) model to genuinely assess the impact of new legislation on business;
- extend and reform the 'Back to Education Allowance';
- switch the R&D tax credit to a volume based" approach to allow Ireland to compete with other countries (the UK, Spain) in attractive research intensive mobile foreign investment projects;
- give SMEs a PRSI offset to support employee upskilling; and
- restore national economic competitiveness by:
  - freezing increases in utility costs and Government charges;
  - use the downturn in the construction industry as an opportunity to invest in national infrastructure;
  - developing next generation broadband access for business and educational facilities; and
  - reverse the increase in VAT rates."
