- the strong links that alcohol advertising has to sponsorship of sport and other cultural activities;
- that advertising of alcohol portrays a simple social activity and one to be encouraged;
- that alcohol advertisements hold a strong appeal for young people and are considered by young people to be stylish and humorous, showing alcohol as promoting a desirable lifestyle, and helping to improve confidence in social skills (the Impact of Alcohol Advertising on Teenagers in Ireland 2001);
- that measures are needed to curtail the demand for alcohol, to complement the measures introduced in the Intoxicating Liquor Act 2008, which restricts the supply of alcohol;
- that voluntary codes of practice on the promotion and advertising of alcoholic drinks is entirely ineffective;
- advice from the Irish Medical Organisation’s former President, and public health specialist, Dr. Joe Barry that all alcohol advertising should be banned;

- a call from the Irish College of Psychiatrists (September, 2008) for a complete ban on all alcohol advertising in Ireland;
- the positive impact of France’s ban on all televised advertising of alcohol and sponsorship of sport by the alcohol industry introduced in its 1991 Law, Loi Evin;

- introduce without delay a total ban on all advertising of alcohol in Ireland.”

- the process of gathering evidence traumatizing for victims;
- it is traumatizing for witnesses to testify in front of the accused and their associates in the court room;
- there is a concern that the State is ‘ticking boxes’ in its efforts to ratify the Council of Europe Convention on Action against Human Trafficking but not adequately addressing victim’s needs;

calls on the Government to;

- mandate the organized crime section of the Gardaí to police human trafficking and deal with victims of the crime;
- act so that Gardaí in organized crime get specialized training to deal with this issue;
- establish a joint investigation unit to so as to police human trafficking on the island of Ireland more effectively- human trafficking by its nature is a transnational organized crime and in Ireland's situation it is exacerbated by our loosely monitored border;
- include all of Article 14 of the Council of Europe Convention when it comes to granting victims residency in Ireland so that victims of human trafficking in Ireland will be given protection and assistance based on their human rights;
- follow the advice of the EU Commission's Expert Group on Trafficking in Human Beings;
- extend the Recovery and Reflection period to 3 months and provide it immediately when someone is identified as a suspected victim;
- ensure the identification of suspected victims of trafficking happens in collaboration with law enforcement and victim support agencies;
- commit to granting the 6 month Temporary Residency Permit immediately to victims when they begin co-operating with the criminal investigation;
- relieve victim trauma by ensuring victims have the option of giving evidence by video and testifying in court by video link;
- include as part of policy the promotion of exit routes to enable women to move out of prostitution and trafficking situations; and
- follow the lead of Sweden, Norway and Iceland by criminalizing the purchase of sex so as to target the demand for the sex exploitation industry."
