That Seanad Éireann reaffirms the long-standing support of the Irish Government and people for the establishment of a Palestinian State, based upon Israel’s pre-1967 borders with mutually agreed land swaps, and backs the continuing efforts of the Government, in conjunction with EU and international partners, to advance its earliest possible realisation, through the resumption of direct peace talks between the Israeli and Palestinian sides aimed at achieving a comprehensive negotiated two-State resolution of the conflict on the basis of the parameters set out in the EU Foreign Affairs Council Conclusions of December, 2009, December, 2010 and May, 2011 and in full accordance with relevant Security Council resolutions, the Madrid Principles, the 2004 Roadmap, previous agreements entered into by both parties and the Arab Peace Initiative.”

- raise the issue of gendercide at UN and EU level, with a view to proactively challenging states like China and India to abandon coercive population limitation policies, to repeal laws that reinforce bias against baby girls, and to take steps to counter the negative cultural attitudes towards women that underpin and motivate the bias against baby girls, leading to gendercide;
- ensure that recipients of Irish foreign aid do not promote gendercide.”
