Subject to notice of motion and the acceptance of such motion by the Cathaoirleach, the proceedings on a Motion regarding Biodiversity shall commence at 3.15 p.m. and shall, if not previously concluded, be brought to a conclusion after two hours and any division demanded thereon shall be postponed until
