recognises that:

- the choices of individuals and companies are now severely limited regarding the provision of basic financial services especially with local access;
- both personal and business consumers are paying over the odds on their mortgages and loans with only the prospect of increased interest rates going forward;
- reliance of our remaining financial institutions on online solutions actively discriminates against certain cohorts of the population;
- credit unions have limited scope to provide financial services to business customers e.g. personal current accounts only, and lack the expertise to fully serve this important sector; credit unions are not banks and do not want to be banks;
- the lack of availability of, and appetite for, credit by our SMEs, is constraining the growth of our economy as these are the backbone of the economy and provide the vast majority of employment;

- separately, the review of the credit union movement is due to be completed imminently, members of the Government openly talk of the credit unions filling the gap left by Ulster Bank and KBC thus pre-empting the conclusions of this review along with the Banking Review;
