 - (b) beidh Buan-Ordú 30 arna chur ar fionraí;
 - (c) ní bheidh aon Ord Gnó ann;
 - (d) ní thógfar de ghnó ach amháin na hítimí atá leagtha amach sa Sceideal a ghabhann leis an mír seo agus, dá réir sin, ní thógfar aon ghnó eile mura n-ordóidh an Seanad a mhalaírt ar thairiscint arna déanamh ag Treoráí an Tí nó ag cibé Seanadóir eile a údaróidh sí chuige sin.
- (1) That, notwithstanding anything in the Standing Orders relative to Public Business, the Seanad on its rising on Wednesday, 8th March, 2023, shall adjourn until 9.30 a.m. on Thursday, 9th March, 2023, and the following arrangements shall apply:
- (a) Commencement matters shall be taken in accordance with Standing Order 29;
 - (b) Standing Order 30 shall stand suspended;
 - (c) there shall be no Order of Business;
 - (d) the business to be taken shall be confined to the items set out in the Schedule to this paragraph and, accordingly, no other business shall be taken unless the Seanad shall otherwise order on motion made by the Leader of the House or such other Senator as she may authorise in that behalf.

Stages.

Subject to the passage by the Dáil of the Environmental Protection Agency (Emergency Electricity Generation) (Amendment) Bill 2023 [Dáil], the proceedings on Second Stage shall be taken at 10.30 a.m. and shall, if not previously concluded, be brought to a conclusion after 75 minutes. The opening contribution of the Minister at the debate on Second Stage shall not exceed 8 minutes, the contribution of all Senators shall not exceed 5 minutes, and the Minister shall be given no less than 8 minutes to reply to the debate. Committee and Remaining Stages shall be taken immediately thereafter and the proceedings thereon shall, if not previously concluded, be brought to a conclusion at 2 p.m. by one Question, which shall be put from the Chair, and which shall, in relation to amendments, include only those set down or accepted by the Government.
