### ANTI-SOCIAL BEHAVIOUR

The within Resolution was passed by Dáil Éireann at its Meeting on this 18th day of September, 2025.

Go ndéanann Dáil Éireann:

- a aithint go bhfuil iompar frithshóisialta ina fhadhb mhór in Éirinn i gcónaí do dhaoine de gach aois;
- á thabhairt dá haire gur tosca ilghnéitheacha iad na tosca is cúis leis an iompar seo, agus go bhfuil roinnt oibre déanta go dtí seo chun réitigh a aithint agus acmhainní a chur ar fáil dóibh;
- á ghlacadh leis go bhfuil líon na nGardaí in aghaidh an duine den daonra fós i bhfad níos ísle ná na leibhéil is fearr;
- aitheantas a thabhairt don easpa cumhachta a airíonn go leor daoine maidir le dul i ngleic leis an bhfadhb leanúnach seo, go háirithe nuair is daoine atá faoi bhun 18 mbliana d'aois a bhíonn ina bun agus is féidir leo an iliomad cionta a dhéanamh sula ndéileáiltear leo faoin gcóras reatha;
- a ghealladh tuilleadh acmhainní a chur ar fáil chun dul i ngleic le bunchúiseanna an iompair fhrithshóisialta ag daoine faoi aois, agus béim mhór bhreise á leagan ar iarmhairtí láithreacha a bheith ann do na gníomhartha a dhéantar; agus
- a ghealladh liosta iomlán d'athchóirithe reachtaíochta agus acmhainní a sholáthar, ar athchóirithe iad is féidir a chur i bhfeidhm, le leagan faoi bhráid Thithe an Oireachtais laistigh de shé mhí tar éis an tairiscint seo a rith, agus bunófar an liosta sin ar óráidí a rinneadh le linn na díospóireachta seo, ar an dea-chleachtas in Éirinn agus go hidirnáisiúnta, agus déanfar na bearta seo a leanas a mheasúnú go sonrath:
  - cuirfiú a thabhairt isteach do chiontóirí athuaire;
  - cúirteanna pobail chun cionta i ndáil le hiompar frithshóisialta a bhreithniú go tapa, lena n-áirítear Orduithe um Iompar Frithshóisialta a cheadú;
  - Orduithe um Iompar Frithshóisialta a cheadú gan a cheangal ar Ghardaí a bheith i láthair sa chúirt;
  - nithe ardluacha a úsáidtear i

That Dáil Éireann:

- recognises that anti-social behaviour continues to be a major problem in Ireland for people of all ages;
- noting that the factors leading to this behaviour are multi-faceted and that some work has been done to date to identify and resource solutions;
- accepting that Garda numbers per head of population remain far short of optimal levels;
- acknowledges that many people feel a sense of powerlessness to deal with this persistent problem, especially when those involved are aged under 18 years of age and can commit multiple offences before being dealt with by the current system;
- undertakes to provide additional resources to tackle the root causes of underage anti-social behaviour, with an additional strong emphasis on immediate consequences for actions; and
- commits to providing a full list of implementable legislative and resourcing reforms to lay before the Houses of the Oireachtas within six months of this motion being passed, based on contributions made during this debate, best practice in Ireland and internationally, and specifically assessing the following measures:
  - the introduction of curfews for repeat offenders;
  - community courts for rapid adjudication on anti-social behaviour offences, including the sanctioning of Anti-Social Behaviour Orders (ASBOs);
  - ASBOs to be sanctioned without requiring Gardaí to turn up in court;
  - immediate seizure on a permanent
