

#### Forum on a Family Friendly and Inclusive Parliament

The Forum on a Family Friendly and Inclusive Parliament is seeking submissions from relevant organisations and members of the public.

#### **Background**

The Forum was established by the Ceann Comhairle of Dáil Éireann on 23 March 2021. The principal focus of the Forum's work will be to look at the Houses of the Oireachtas and how it is organised. The aim of the Forum is to:

- make practical recommendations on how to make the Houses of the Oireachtas a more inclusive, family friendly, and gender-sensitive workplace for the parliamentary community;
- ensure that the Houses of the Oireachtas are supported and resourced to take account of gender and equality issues when legislating; and
- improve the diversity of the parliamentary community to better reflect society in Ireland.

While the Forum is aware of the role of the National Parliament in the wider policy and legislative context, for this work, the Forum is particularly interested in *practical* and *achievable* recommendations that the Houses can themselves implement. While the Forum is conscious that much work has been done by many organisations to support people from various backgrounds, the Forum's focus is now on family friendly and inclusive supports and measures required for elected members, their staff and for staff working for the Houses of the Oireachtas Service. Many organisations and individuals have expertise in this area or have considered similar changes; the Forum would appreciate all those willing to share their expertise and knowledge with it, as the National Parliament seeks to make improvements. The Forum will consider any suitable written submissions received as evidence and may also decide to invite a number of contributors to virtual meetings.

It is hoped that any improvements recommended by the Forum will benefit members of the parliamentary community, by which the Forum understands to include elected representatives, staff of elected representatives, staff of political parties/groups and staff of the Houses of the Oireachtas Service.

#### **Closing date**

The Forum is tasked with bringing forward recommendations to the Ceann Comhairle by **31 October 2021**. It would, however, be particularly useful for the Forum to receive submissions at the beginning of its work, ideally by **Thursday 7 May.** However, the Forum may accept submissions received after that date.

#### How to send your submission

Please email an electronic document (searchable PDF or equivalent) to <a href="mailto:forum@oireachtas.ie">forum@oireachtas.ie</a>. There is no need to send hard copies of your submission, as this may cause confusion and duplication.

Please do not send your submission to individual committee members. The Secretary to the Forum will ensure all members receive copies of all submissions.

#### What to include in your submission

Your submission should comprise the **submission document** with a separate covering letter or the body of your email constituting a **separate covering letter**. For information on which information to include, please see the draft template on page 4. This will allow the Forum to publish your submission without your contact details. Do not include any personal contact details in your submission document, as the Forum may publish it.

#### In the submission document, please include:

- a brief introduction, for example, explaining your area of expertise
- any factual information that you have to offer from which the Forum might be able to draw conclusions, or which could be put to other parties for their reactions
- links to any publications you refer to; there is no need to send such publications as attachments
- any recommendations to the Forum with a focus on the questions asked on Page 5 below; be as specific as possible and summarise your recommendations at the end of the document
- if your document is more than 10 pages long, an executive summary of the main points made in the submission

Please remember to number your pages.

#### Tips on writing your submission and important information

- Keep your submission concise and to the point. Please do not include any unnecessary or superfluous material that does not relate directly to the topic.

- The Forum cannot consider submissions which deal with matters outside its remit.
- The Forum cannot consider submissions which deal with individual cases.
- Submissions sent to any other email address may not be accepted.
- Anonymous submissions cannot be accepted and will be rejected.
- Petitions and form letters may not be accepted or published.
- Submissions made to the Forum may be published as received, either as part of a Committee report or separately, if the Forum decides to do so.

#### Making a submission is a public process

The Forum is not obliged to accept your document once it has been submitted, nor is it obliged to publish any or all of your submission if it has been accepted. However, the operations of a parliament are a public process, and you should be aware that any submissions made to the Forum, including your identity, may be published either as part of a Forum report, or separately, if the Forum decides to do so.
